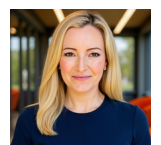

Tax reporting

Tax reporting preparation was taking the tax team 4 weeks to complete.

By enhancing their ONESOURCE Corporate Tax implementation and adding two Alteryx workflows with API integrations, we automated both data extraction for group reporting purposes and statutory reporting tax disclosure preparation cutting out weeks of manual effort.

The new process enhanced efficiency, improved accuracy and simplified the audit. It created time for the team to focus on tax position analysis and delivering additional value to the business.

Indirect tax
